2009 Annual Report

2009 brought many challenges, opportunities and accomplishments to the Free Clinic of Simi Valley and each of them brought many changes as symbolized on the cover of our 2009 Annual Report. First are the patients in 2009 we touched 11,762 individuals which is an 8% increase over 2008 and the most in our 38 year history. As each of them say, the Clinic made a positive change in their health and well being.

While we were busy seeing people who were in need of healthcare services. We transitioned from paper files to electronic which freed precious space in our building and provided easier access to patient records. This change was made possible through the enormous generosity of **Dr Russell Noblett** of Med-Kind.

Kaiser Permanente continued to play a vital role in our ability to help those in need of medical care. In 2009 Kaiser provided three attending physicians, **Dr. Tantrphol, Dr. Mahallati** and **Dr. Sam** who supervised 18 resident physicians and brought our Medical services up to forty hours a week.

Diane Goldenring provided funds to staff our Dental Clinic three days a week and provide training opportunities to dental hygiene students from Oxnard College and West Los Angeles College. These students worked under the supervision of **Gregory Cole, DDS** and grew from students to experienced professionals.

The Free Clinic continues to provide innovation through our Pharmacist Ambulatory Care Program. **Robert Deamer** Pharm D. headed a program that brought two new ambulatory care pharmacists Erin Mahoney and Leslie Fisher. In addition Dr. Mahoney and Dr. Fisher provided health education workshops on prevention of diabetes and hypertension.

Simi Valley Hospital expanded their support by providing laboratory services surplus supplies and equipment. Our relationship with the hospital will continue to change for the better in 2010 as we continue to work with together to improve the health of the medically underserved.

Counseling services remained steady under the guidance of **Kristy Schadt** and her team of volunteer Marriage and Family Therapists. Our program focuses on providing positive change in the lives of children impacted by trauma.

Ron Whiteman, our longest serving volunteer, continued his commitment to providing quality legal services to those in need. Ron and his team of volunteer attorneys worked closely with individuals and families this year assisting more people bankrupsy and financial issues.

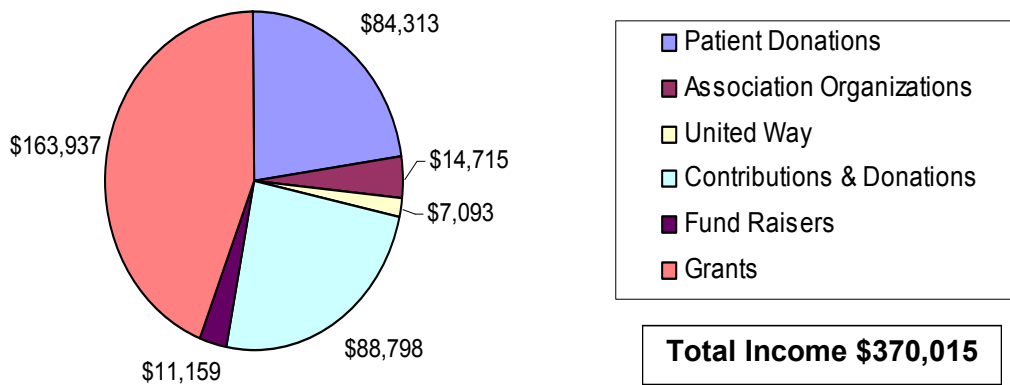
